The accounting system for the lunch and breakfast program is completely computerized. All meals must be paid in advance. Extra Milk .50

## Fee Waivers.

Parents of secondary age students are required to verify income with the school secretary if requesting a fee waiver.

As stated in District Policy, Middle and High School Students *will not* be allowed to charge meals.

Elementary students should only charge in an emergency. A maximum of *five elementary* school emergency meals can be charged. After that, students will not be allowed to eat school meals.

<u>High School Seniors</u> requesting a refund must do so through the District Office, located Huntington, Utah, before the end of **June**, the year of graduation.

We do not give change. This rule applies to both cash and checks. All money that we receive will be applied to your child's lunch account. Please remember to include the child's account number on the check. We also have an online payment option available.

We recommend that parents deposit at least one week's lunch and/or breakfast money in their child's account at a time. We accept and encourage payment for each full term or the entire year.

Money must be put in the student's account before the student goes through the cafeteria line. There must be sufficient money in the account to pay for that day's meal. Remember, it can take 2 days or more for funds to be deposited if online payment is made.

Deficit notices are sent to parents of students whose accounts are in the negative. Please take note of the date of this notice. The amount listed will bring the student's account current only to that date. The amount paid after the date of the deficit notice should reflect meals charged since the notice was sent and include payment for future meals as well.

## Information on applying for free or reducedprice meals.

## Family Free and Reduced application should be filled out online at www.aspire.emeryschools.org

- These benefits do not start until the application has been approved. Parents may log back in to aspire after 48 hours and check the status of the application.
- When parents submit an application for free or reduced-price meal benefits, they will be notified by mail of their child's qualification status.
- When a student qualifies for free meals, he/she goes through the cafeteria line without charge. Only the computer operator (who keeps this information confidential) knows if a student is receiving free, reduced, or paid meals.
